

The U.S. Consulate General is located at 220 Anna Salai (near Gemini Flyover) Chennai 600 006. It serves the states of Tamil Nadu, Kerala, Andhra Pradesh and Karnataka and the Union Territory of Puducherry and Lakshadweep. The Consulate's Public Affairs Section (PAS) is located at the Consulate premises. PAS is responsible for public diplomacy activities for the United States Government in Southern India. PAS section plans and organizes seminars, lectures and discussions around visiting U.S. Speakers, Voluntary Speakers, Fulbright Professors and U.S. Government officials. It also organizes longer-term Academic and cultural exchange programs involving American experts and coordinates and implements a grants program. In addition, the section arranges cultural presentations and exhibits of works by American artists. It also maintains an extensive state-of-the-art library, and provides current and accurate information about the United States to patrons throughout South India through its vast collection of books, journals, newspapers, videotapes and CD-ROMS.

About the topic

The United Nation's most recent report on climate change has underscored that this issue represents the greatest civilisational threat to human beings and life on Earth. Freshwater shortages; declines in food production; plant and animal extinctions; more deaths from floods, storms, heat waves and droughts; economic and political instability... the list of predicted impacts of climate change is long and urgent. The scientific evidence is overwhelming and the need for action now understood to be greater than ever. Poor countries are at the greatest risk and will suffer the most. In India, it is predicted that 40% of Himalayan glaciers will vanish; the Ganga delta turn infertile; 25% of wildlife perish; food and water shortages become chronic; and pestilences such as dengue and cholera spread. These environment and health impacts will be joined by human misery, economic dislocation, conflict and security challenges of an unprecedented scale. The UN's Intergovernmental Panel on Climate Change (IPCC) has sounded the alarm bell - global emissions of greenhouse gases must reduce to 85% by 2050.

About the film

Director David Guggenheim eloquently weaves the science of global warming with Al Gore's personal history and lifelong commitment to reversing the effects of global climate change in the most talked-about documentary of the year. "An Inconvenient Truth" makes the compelling case that global warming is real, man-made, and its effects will be cataclysmic if we don't act now. Gore presents a wide array of facts and information in a thoughtful and compelling way: often humorous, frequently emotional, and always fascinating. In the end, An Inconvenient Truth accomplishes what all great films should: it leaves the viewer shaken, involved and inspired.
